Amendment # 1 - ELECTED OFFICERS AND DUTIES OF OFFICERS

Secretary to keep roster in accordance with new Standing Rule #6.

Amendment # 2 – ELECTION OF OFFICERS

Removal of rule that Vice President, Secretary and Treasurer, who serve one-year terms, be elected by mail vote in the non-conference year.

Amendment #3 – ELECTION OF OFFICERS

All officers to serve a 2-year term.

Amendment # 4 – CONFERENCE

To allow conference information to be e-mailed rather than snail-mailed.

Amendment #5 – CONFERENCE FEES

To eliminate the club payment of a Region Conference fee if no conference is held that term.

Amendment # 6 – LEADERSHIP DAY

To specify requirements for a Leadership Day on the non-conference year.

Amendment #7 – NORTHEAST REGION ROSTER

To specify deadlines for clubs to submit roster information to the Region Secretary.

NOTICE OF MOTION

To restructure the Region Board.

EDITORIAL CHANGES

The following editorial changes have been done automatically by the Bylaws Chair.

- The following Bylaws and Standing Rules were amended by inserting "or biennial" after "annual" to bring them into accordance with Bylaw 9.1:
 - 6.2 The president shall:
 - **6.2.1.b.** arrange and preside at the annual *or biennial* conference and board meetings.
 - **6.2.1.g.** arrange for an annual *or biennial* management training for councils and clubs/chapters.
 - 14.1. These bylaws may be amended at any annual *or biennial* Conference by a two-thirds (2/3) vote or by a mail vote with two-thirds (2/3) of all member clubs/chapters in good standing voting in favor of the amendment. All amendments shall be presented in writing to the member clubs/chapters at least thirty (30) days prior to the voting. All amendments adopted at the conference shall become effective August 1 following conference, unless otherwise specified.

Standing Rule 2.1:

An annual *or biennial* region conference shall be held the first weekend in June unless otherwise directed by the region board.

Standing Rule 8.4: CONFERENCE TRAVEL EXPENSE.

Officers' travel to and expenses in connection with the pre-and-post-conference board meetings shall be included in the Northeast Region budget and shall not be included in calculating the cost of the annual *or biennial* conference. Travel and meeting expenses of officers elected at the conference shall not be reimbursed for the post-conference board meeting.

• Bylaw 7.4. ELECTION OF OFFICERS.

Sections 7.5 and 7.6 were renumbered to 7.4.6 and 7.4.7 for consistency.

Section 7.4.6 was amended by deleting "Vice president and secretary" and inserting "Vice President, Secretary and Treasurer", and by deleting "one (1) year" and inserting "their full term", to read:

TERM. Officers shall take office at the beginning of the fiscal year. The President and President-Elect shall serve for two years. The *Vice President*, *Secretary and Treasurer* shall serve for one year. Officers shall serve for *their full term* or until a successor takes office, or until removed by resignation, death, or by adoption of a motion by member clubs/chapters with notice and a two-thirds (3/3) vote.

This amendment was to keep the section in accordance with Bylaw 7.4.1.

- 4.4 The Northeast Region Board of Directors will be responsible for coordinating the Leadership Day location and events.

Rationale:

The region will be best served by holding a Leadership Day on the non-conference years to keep continuity in the region's on-going education and training.

- 6.2 Updates to the roster will be published on January 1 and March 1 each term.

Rationale:

The Northeast Region Roster is an important tool in our POWER*talk* activities. It is <u>vital</u> that members provide the information to the Region Secretary in a timely manner so that all members can communicate effectively with the membership.
